Articles of Attention

SPG: Art by Fire Sale

1. No blocking of Fire Exits: Must observe taped area on floor
2. No nails in the walls: Must supply any vertical supports you may need
3. No tape on the walls
4. No parking on the grass in vicinity of Shepard Garden and Art Center
5. No late arrivals will be permitted: Participant must be completely set up 15 minutes prior to doors opening. Participants must be on premises 45 minutes prior to door opening or their assigned space will be moved to an extra or outdoor space if available and original space will be re-assigned.
6. Please refrain from blocking other participants booth or space for prolonged periods of time.
7. You must have copy of your seller's permit/tax id at booth during show
8. You must either collect appropriate sales tax or display a sign at your booth that sales tax is included in purchase.
9. If you cannot be packed up and out of your spot at the end of the show within the allotted time (1 hour) you are expected to alert the show coordinator as soon as you can, so we can get some assistance for you. Otherwise, there is a charge for overtime.
10. **Do not break down your space before the show closes. It is disruptive to the participants that have last minute sales.**
