Alpha Fired Arts has opened up their gallery for the **3rd Annual SPG: Art by Fire Membership Exhibit**. SPG: Art by Fire will post entry requirements and gather membership entries. Then, members will drop off their pieces directly to Alpha Fired Arts on drop off dates with paperwork. SPG: Art by Fire will publicize the event in addition to what Alpha does. We will work with Alpha Fired Arts and co-ordinate publicity. Each member can submit 1-3 pieces for the Membership Exhibit. The first piece by each member will all be accepted, and on a space available basis, pieces 2-3 according to date submitted. If the show is not full by the entry deadline, late entries will be considered for acceptance. *Alpha Fired Arts' commission applies to all sales in the show during the exhibition (50%).*

For publicity: Make sure you take professional quality photos with a plain background and clarity of image. Please send these to sonya@schumacherceramics.com with your entry submission by June 14th (late photos may be accepted if you let us know when you can have them). Send at least the first entry image with application.

Delivery, Reception, and Pick-up:

Delivery of your accepted work(s) (remember it is on a space available basis after first entry): Drop off directly at Alpha Fired Arts, 4675 Aldona Way, Sacramento on Tues., July 23, from 10am-4pm. If you cannot be there another member may drop off your work if you include your signed paperwork. You can bring work earlier and put it in the warehouse.

The opening reception will be on Second Saturday, August 10, from 2pm - 4pm. Refreshments are provided by Alpha.

Picking up your work: Pick up unsold work directly from Alpha's **Gallery on Friday, Sept. 7 or Saturday, Sept. 8 from 10am - 4pm**. All work will need to be picked up by artist at Alpha Fired Arts Gallery (if you cannot do so, make arrangements with another member).

All entries for the Membership Exhibit will need to go through the artbyfire.org application. All work will need to be delivered directly to Alpha Fired Arts Gallery and also picked up by artist at Alpha Fired Arts Gallery (if you cannot do so, make arrangements with another member). Not following submission guidelines will disqualify you from participating in this exhibit.

2. Cannot submit what was entered in a previous Art by Fire Membership Exhibit.
3. You need to send this label page and at least one image of what you are submitting by June 14th to sonya@schumacherceramics.com (or US mail as stated).
4. Make a separate copy of label pages for you to attach to the base of your pieces at delivery.
5. Bring signed Hold Harmless Waiver and labeled piece(s) to Alpha Gallery on delivery dates.
